
Electoral Registers & Voters Lists





Electoral regsiters are a useful source for local and family historians as they list persons eligible to vote in Parliamentary elections by their place of residence or address

Registers have been compiled annually since 1832. Until 1974, the registers were compiled for each Parliamentary Constituency or division in the county. Thereafter, they were compiled by the Electoral Registration Officer for the appropriate District Council and the registers follow local authority, rather than Parliamentary boundaries.

Who could vote?

Prior to **1832** there was no fixed qualification for the franchise. Eligibility depended upon local circumstances and tradition. The 1832 Reform Act added householders of property of £10,000 or more in annual value in towns, and £10.00 copyholders and others in counties.

In 1867 the vote was extended to all householders who had been in residence for at least 1 year and to all lodgers paying £10.00 a year or more in boroughs. In counties it was to all occupiers of houses rated at £12.00 or more and all householders with property of at least £4.00 annual value.

In **1884** the county franchise was brought into line with the boroughs. Even then only 59% of the adult male population could vote. Women could vote if they had relevant property qualifications.

In 1918 the property qualification was abolished - all men over 21, women over 30 and soldiers and sailors over 19 were eligible to vote.

In 1928 women aged 21 and over could vote i.e. male and female adult franchise was awarded.

In 1948 plural voting i.e. a vote for both home and place of business was abolished.

In 1969 the voting age was lowered to 18.
